# AN ORDINANCE OF THE CITY OF JEANNETTE AUTHORIZING THE ACQUISITION OF PROPERTIES AND THE FILING OF CONDEMNATION PROCEEDINGS IN FURTHERANCE OF PHASE II OF THE EMERGENCY STREAM BANK PROTECTION PROJECT

WHEREAS, the Commonwealth of Pennsylvania, Department of Environmental Protection (hereafter referred to as "The Commonwealth") has entered into agreements, dated May 18, 1988 and December 16, 1996 (hereafter referred to as "Agreements) with the City of Jeannette, County of Westmoreland and Commonwealth of Pennsylvania, (hereafter referred to as "The City"), whereby the Commonwealth has agreed to install certain flood control improvements along the channel of Brush Creek and three (3) of its tributaries, (hereinafter referred to as "The Project"), also known as "Project No. DGS 182-7", to alleviate, in part, flood damage and to prevent, as much as feasible, the recurrence of flood damage; and

WHEREAS, in accordance with the aforesaid Agreements, the City is required to provide all lands, easements, rights-of-way, rights of entry, and permits from adjoining land owners, utilities and political subdivisions necessary for the successful construction and future maintenance of the Project; and

WHEREAS, the City is empowered, under the Eminent Domain Code of Pennsylvania, 26 P.S. §1-101 et seq. and the Third Class City Code, 53 P.S. §37801, to exercise the power of eminent domain and enter upon, appropriate, take, use and occupy property in furtherance of the aforesaid project.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HERE, IT IS HEREBY ORDAINED AND ENACTED AS FOLLOWS:

- 1. **PROPERTIES TO BE ACQUIRED**. The properties itemized in Exhibit "A" attached hereto and more particularly identified in the attached surveys shall be acquired by the City for the purposes of the Project.
- 2. <u>CONDEMNATION/FILING DECLARATION(S) OF TAKING</u>. The Declaration of Taking containing those Offers of Just Compensation for the real property interests referenced therein, as same is attached hereto as Exhibit "B", is hereby approved by the Council of the City of Jeannette. Such Declaration shall be filed upon final passage of this Ordinance by the Solicitor of the City of Jeannette.
- 3. ACQUISITIONS IN LIEU OF FORMAL CONDEMNATION

  PROCEEDINGS. Nothing in this Ordinance shall be deemed to require the City to attempt alternate means of acquisition prior to the formal filing of a Declaration of Taking, however, amicable property acquisitions are hereby authorized in furtherance of this Project, in accordance with the terms and conditions of the Agreements with the Commonwealth.
- 4. <u>FUTURE ORDINANCES FOR PROPERTY ACQUISITION</u>. Nothing in this Ordinance shall preclude the passage of a supplemental Ordinance or Ordinances authorizing the acquisition of additional properties required in furtherance of the Project.
- 5. **RECORDING**. A copy of this Ordinance shall be recorded within thirty (30) days after its enactment in the Office of the Recorder of Deeds in and for Westmoreland

County, Pennsylvania and shall be indexed in the name of the property owners affected hereby; and a copy of this Ordinance, without all Exhibits, but containing sufficient notice and information to advise such property owner of the nature and extent of the taking and the Just Compensation for the interest in property to be acquired, shall be sent by registered mail to each owner of property referenced in Exhibit "A" attached hereto, at his or her last known address.

6. **EFFECTIVE DATE**. This Ordinance shall become effective immediately.

- 4. The purpose of the condemnation is to implement the Emergency Streambank Protection Project ("Flood Control Project"), in conjunction with the Borough of Penn, and the Commonwealth of Pennsylvania, Department of Environmental Protection, to alleviate, in part, flood damage to, and to prevent, as much as feasible, the recurrence of flood damage, within the City of Jeannette. The Flood Control Project will involve the construction of a series of storm water drains and culverts under and over, *inter alia*, those properties referenced herein, the full listing of which, together with their identifying Westmoreland County Tax Map Parcel numbers is set forth on Exhibit "A" attached hereto.
- 5. The rights-of-way and easements condemned, together with a declaration and offer of just compensation for same, are set forth in the property descriptions and surveys attached hereto as Exhibit "B".
- 6. The nature of the title acquired varies from property to property, but are generally in the way of property acquisitions, permanent easements, temporary construction easements, and occasional flowage easements as more particularly described for each property in Exhibit "B" attached hereto.
- 7. Construction drawings and plans for the City of Jeannette/Penn Borough Emergency Stream Bank Protection Project may be examined at the Office of the Clerk of the City of Jeannette, Jeannette City Hall, 110 South Second Street, Jeannette, Pennsylvania 15644.

8. Notice of filing this Declaration of Taking, which includes the plans of the properties condemned, are on this same day being filed of record in the Office of Recorder of Deeds of Westmoreland County, Pennsylvania, in accordance with 26 P.S. §1-404.

9. Just compensation is secured by way of the City of Jeannette General Obligation Bonds Refunding Series of 1998, having a present balance of and monies escrowed as part of a hazard mitigation grant totaling \$\_\_\_\_\_ dollars. Just compensation is further secured by the funds raised, or lawfully to be raised, by the power of taxation of the City of Jeannette, which funds are deemed pledged and hereby made security for the payment of damages as shall be determined by law; accordingly the City of Jeannette is not required to file a bond with this Declaration of Taking, pursuant to 26 P.S. §1-403 (b).
