ORDINANCE NO.04-15

AN ORDINANCE OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA AMENDING ORDINANCE NUMBER 99-5 TO PROVIDE A SCHEDULE OF FEES FOR THIRD PARTY BILLING AND SERVICE CHARGES FOR EMERGENCY SERVICES AND EQUIPMENT FOR THE CITY OF JEANNETTE POLICE DEPARTMENT AND FIRE DEPARTMENT

WHEREAS, the City of Jeannette on or about September 8, 1999 adopted Ordinance No. 99-5:

"AN ORDINANCE OF THE CITY OF JEANNETTE, AUTHORIZING THIRD PARTY BILLING AND SERVICE CHARGES FOR EMERGENCY SERVICES AND EQUIPMENT."

WHEREAS, such Ordinance authorized the City of Jeannette Fire Department and Police Department to bill insurance carriers for services rendered to Third Parties in emergency situations wherever such services may be covered by liability or hazard insurance; and

WHEREAS, the City previously adopted a Schedule of Fees utilized by the Fire Department of the City of Jeannette in such Third Party billing circumstances; and

WHEREAS, the Council of the City of Jeannette desires to amend such
Ordinance to include a Fee Schedule for Third Party billing for the City of Jeannette
Police Department and to provide for the modification of such Fee Schedules from time to time by Resolution.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE CITY OF JEANNETTE HEREBY ORDAINS AND ENACTS AS FOLLOWS:

1. Paragraph No. 2 of Ordinance No. 99-5 is hereby amended to read as follows:

"Those services for which billing may occur and the fees associated with same are set forth for the City of Jeannette Fire Department in the Schedule of Services and Fees attached hereto, made a part hereof and marked "Exhibit A". Those services for which billing may occur and the fees associated with same for the City of Jeannette Police Department are set forth in the Crash/Injury Severity Charge Summary attached hereto, made a part hereof and marked "Exhibit B".

2. Paragraph 3 of Ordinance No. 99-5 is hereby amended to read as follows:

"The Schedule of Fees and Services for the Fire Department of the City of Jeannette attached hereto as Exhibit "A" and the Crash/Injury Severity Charge Summary for the City of Jeannette Police Department as attached hereto as Exhibit "B" may be amended from time to time by the Council of the City of Jeannette by Resolution".

3. All other parts or portions of City of Jeannette Ordinance No. 99-5 not otherwise modified by this Ordinance shall remain and continue in full force and effect.

## COURT TIME AND WITNESS INTERVIEW @\$80/hr

Fatal: Crash resulting in death of an individual within 30 days of the accident

A-Level: Crash with one incapacitating injury

B-Level: Crash with one person with a visible injury but not incapacitating

C-Level: Crash with one person with a possible injury

PDO: Property Damage Only with a value of \$500 on any single vehicle resulting in a Claim filed to an insurance company or if cited individual is without insurance.
