ORDINANCE NO. 05-08

AN ORDINANCE OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA AUTHORIZING THE CONSTRUCTION OF STOP SIGNS ON THE CART WAY RUNNING PARALLEL TO LAFFERTY STREET, BETWEEN STATE STREET AND THOMAS AVENUE, IN THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA

WHEREFORE, the Council of the City of Jeannette is permitted to authorize the construction of and to construct certain traffic control devices to regulate and control the operation of traffic along roadways within the City; and

WHEREAS, the Council of the City of Jeannette is empowered to adopt
Ordinances for the construction of traffic control devices at intersections of public
roadways within the geopolitical boundaries of the City; and

WHEREAS, the Council of the City of Jeannette has determined that the current and existing traffic patterns along that cart way running parallel to Lafferty Street, between State Street and Thomas Avenue, within the City of Jeannette adversely affects the health, safety and well being of pedestrians and the operators of motor vehicles along same, and, accordingly, requires the construction of traffic control devices at the intersections referenced hereafter; and

WHEREAS, the Council of the City of Jeannette, Westmoreland County,

Pennsylvania believes it is necessary to enact an Ordinance providing for the construction

of traffic control devices at the aforesaid intersections to control such traffic patterns.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE CITY OF JEANNETTE HEREBY ORDAINS AND ENACTS AS FOLLOWS:

- 1. That stop signs be erected along that cart way running parallel to Lafferty

 Street, at its intersection with both State Street and Thomas Avenue, to control the flow

 of traffic proceeding in both the northerly and southerly direction along same, as it enters

 State Street and Thomas Avenue.
- That such stop signs be constructed and installed under the direction and supervision of the City Foreman and Chief of Police of the City of Jeannette,
 Westmoreland County, Pennsylvania.
- 3. That, following the construction of said stop signs, the failure of any person to stop and/or abide by such signs shall be punishable as a summary offense and the imposition of a fine and/or other penalties consistent with other Ordinances existing within the City of Jeannette and/or the laws of the Commonwealth of Pennsylvania for failure to obey traffic control devices.

THIS ORDINANCE IS DULY ORDAINED AND ENACTED BY THE COUNCIL OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA AT A PUBLIC MEETING HELD THE 13 DAY OF JULY, 2005, AND SHALL TAKE EFFECT IMMEDIATELY.
