ORDINANCE NO. 17-08

AN ORDINANCE OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR 2018 AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR THE SPECIFIC PURPOSES OF THE MUNICIPAL GOVERNMENT, HEREINAFTER SET FORTH, DURING THE CURRENT YEAR.

BE IT ORDAINED AND ENACTED, By the Council of the City of Jeannette, Westmoreland County, Pennsylvania, at a meeting held on the 19th day of December, 2017 that:

<u>SECTION I.</u> That taxes be and are hereby levied on real property and income within the Municipality for the fiscal year 2018 as follows:

Real Estate – For each dollar of assessed valuation:

General Purposes	27.99 mills
Debt Services	3.15 mills
Library	1.24 mills
Public Street Light	1.00 mills
Recreation	0.24 mills
Total	33.62 mills

Earned Income Tax:

Resident	1.75 percent
Non-Resident	1.00 percent

- Residence Tax \$5.00 on all persons over the age of 18 years with the exception of persons over the age of 65 who make application to the City Treasurer for exemption.
- Local Service Tax \$52.00 on all persons working within the City of Jeannette who earn more than \$12,000.00.
- Business Privilege Tax 1/2 mill on gross receipts of wholesale vendors, and 2/3 mill on gross annual receipts of all others, retail and service.
- o Real Estate transfer tax of 1/2 of 1% of consideration of value.

<u>SECTION II.</u> That for the expense for the fiscal year 2018 the following amounts are hereby specifically appropriated from the revenues available for the specific purposes set forth below, which amounts are more fully itemized in the Budget Form.

Department of Public Affairs	\$2,734,267.18
Department of Accounts and Finances	420,640.91
Department of Public Safety	\$1,698,930.33
Department of Streets and Improvements	\$706,130.54
Department of Parks and Public Buildings	\$148,108.58
Total Estimated Expenditures	\$5,708,077.54

<u>SECTION III.</u> The total estimated receipts, including the revenues from the above levied taxes and from all other sources for the fiscal year 2018 which amount is more fully itemized in the Budget Form is \$ _5,708,077.54_

SECTION IV. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.
