ORDINANCE NO. <del>79-</del> 80 - 2

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID THE OFFICERS AND EMPLOYEES OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA, FOR THE YEAR 1980.

BE IT ORDAINED AND ENACTED by the Council of the City of Jeannette, and it is hereby ordained and enacted, as follows:

 $\underline{\text{SECTION I}}$  That the members of the Police Department of the City of Jeannette shall receive the following compensation for the year 1980:

- (a) Chief of Police \$22,348.00 per annum base pay.
- (b) Captain of Police \$20,932.00 per annum base pay.
- (c) Lieutenants, Sergeants, and Patrolmen as per Agreement dated December, 1979.

 $\underline{\text{SECTION II}}$  That the members of the Fire Department of the City of Jeannette shall receive the following compensation for the year 1980:

- (a) Fire Chief \$19,489.00 per annum base pay.
- (b) Fire Captain and Shift Heads as per Agreement dated December, 1979.
- (c) Call Firemen (when filling in for a regular) \$4.56 per hour.

  SECTION III That Police Dispatchers shall be paid during the year 1980 at the rate of \$3.13 per hour.

SECTION IV That Metermaids shall be paid for the year 1980:

- (a) Metermaid \$3.67 an hour.
- (b) Metermaid \$3.50 an hour.

 $\underline{\text{SECTION V}}$  That call firemen shall be paid for the year 1980 at the rate of \$3.50 per hour.

SECTION VI That the City Clerk shall receive the salary for the year 1980 in the amount of \$20,274.00 per annum.

 $\underline{\text{SECTION VII}}$  That the City Engineer shall receive a salary for the year 1980 in the amount of \$4,665.00 per annum.

SECTION VIII That the City Solicitor shall receive a salary for the year 1980 in the amount of \$8,901.00 per annum.

SECTION IX That the personnel of the Community Development Department shall receive salaries for the year 1980 as follows:

- (a) Coordinator \$16,350.00 per annum.
- (b) Housing Inspector A \$10,900.00 per annum.
- (c) Housing Inspector B \$10,464.00 per annum.
- (d) Secretary \$6,540.00 per annum.

SECTION X That the City Tax Collector shall receive a salary for the year 1980 in the amount of \$1,800.00 per annum.

SECTION XI That the personnel of the City Treasurer's Office shall receive salaries for the year 1980 as follows:

Position A - \$2,507.00 per annum.

Position B - \$2,325.00 per annum.

Position C - \$2,289.00 per annum.

SECTION XII City office personnel shall receive salaries for the year 1980 as follows:

Position A - \$7,664.00 per annum.

Position B - \$7,630.00 per annum.

Position C - \$6,540.00 per annum.

SECTION XIII That the members of the Street Department, Sanitation

Department, and Sewage Department, shall receive wages for the year 1980 as

per the Collective Bargaining Agreement between the City of Jeannette and the

Teamsters, Chauffeurs, Warehousemen and Helpers Local No. 30 made in

December, 1979.

 $\underline{\text{SECTION XIV}}$  That the Ordinance Officer shall receive a salary for the year 1980 in the amount of \$10,900.00 per annum.

SECTION XV That the Rodent Control Officer shall receive a salary for the year 1980 in the amount of \$3,708.00 per annum.

SECTION XVI That the Street and Sanitation Foreman shall receive a salary for the year 1980 in the amount of \$15,260.00 per annum.

SECTION XVII That the personnel of the Sewage Department shall receive salaries for the year 1980 as follows:

- (a) Engineer \$21,037.00 per annum.
- (b) Secretary/Clerk \$7,761.00 per annum.
- (c) Assistant \$6,976.00 per annum.
