AN ORDINANCE AMENDING SECTION V OF ORDINANCE NO. 36
OF THE CITY OF JEANNETTE ENTITLED "AN ORDINANCE ESTABLISHING
SEWAGE RENTALS FOR THE USE OF THE SEWAGE SYSTEM AND SEWAGE
TREATMENT WORKS OF THE CITY OF JEANNETTE, AND PROVIDING FOR
THE COLLECTION THEREOF AND THE LIENING OF PROPERTY FOR NONPAYMENT THEREOF; AS AMENDED, AND REPEALING ALL ORDINANCES
OR PARTS OF ORDINANCES INCONSISTENT HEREWITH, SPECIFICALLY
AMENDING THE RATES TO BE CHARGED INDUSTRIAL AND COMMERCIAL
USERS.

BE IT ORDAINED, and it is hereby enacted and ordained by the Council of the City of Jeannette, at a regular meeting thereof, held on the 20 day of

WHEREAS, Council has received recommendations for its consulting engineers to increase the rate charged to commercial sewage customers for usage in excess of 125,000 gallons, and

WHEREAS, Council has determined that the commercial and industrial rates ought to be revised.

NOW, THEREFORE, in consideration of the above, and in order to promote the public health, safety and welfare, Council adopts the following:

SECTION 1. That Section V of Ordinance No. 36 is hereby amended to read as follows:

SECTION V. The following annual rates for service as hereby established.

DOMESTIC USERS

Domestic users shall be charged at the annual rate of Seventy Five and 00/100 (\$75.00) dollars per year.

COMMERCIAL USERS

Rates shall be based on water consumption.
