ORDINANCE NO. 83- 1

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID THE OFFICERS AND EMPLOYEES OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, PENNSYLVANIA FOR THE YEAR 1983.

BE IT ORDAINED AND ENACTED by the Council of the City of Jeannette, and it is hereby ordained and enacted, as follows:

SECTION 1. That the members of the Street, Sanitation and Sewage Departments shall receive wages for the year 1983 as per the collective bargaining agreement between the City of Jeannette and the Teamster's Local 30 executed in December, 1981.

SECTION 11. That the City Engineer shall receive a salary for the year 1983 in the amount of \$29,700.00

SECTION 111. That the City Clerk/Chief Accountant shall receive a salary for the year 1983 in the amount of \$24,600.00

SECTION 1V. That the City Solicitor shall receive a salary for the year 1983 in the amount of \$12,000.00

SECTION V. That the City Foreman shall receive a salary for the year 1983 in the amount of \$18,000.00

SECTION V1. That the Ordinance Officer shall receive a salary for the year 1983 in the amount of \$13,250.00

SECTION V11. That the Health Officer shall receive a salary for the year 1983 in the amount of \$500.00 and the Assistant Health Officee shall receive a salary for the year 1983 in the amount of \$1,000.00

SECTION VIII. That the Clerical employees shall receive a salary for the year 1983 as per the following classifications:

SECTION 1X. That the personnel of the City Treasurer's Office shall receive salaries for the year 1983 as per the following classifications:

Bookkeeper -----\$3,145.00 Office Clerks ------\$2,826.67 Probation ------\$2,650.00 SECTION X. That the metermaids shall receive an hourly wage for the year 1983 in the amount of \$4.04 per hour and that the metermaid probation rate for the year 1983 shall be \$3.65 per hour.

SECTION X1. That the personnel of the Community Development Department shall receive salaries for the year 1983 as per the following classifications:

Coordinator ----- \$19,410.00

Housing Inspector A ----- 12,940.00

Housing Inspector B ----- 12,423.00

Secretary ----- 8,798.00
