ORDINANCE NO. 84-5

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID THE OFFICERS AND NON-UNION EMPLOYEES OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, PENNSYLVANIA, FOR THE YEAR 1984.

BE IT ORDAINED AND ENACTED by the Council of the City of Jeannette, and it is hereby ordained and enacted, as follows:

SECTION 1. That the City Clerk/Chief Accountant shall receive a salary for the year 1984 in the amount of \$25,800.00.

SECTION 11. That the City Solicitor shall receive a salary for the year 1984 in the amount of \$12,500.00.

SECTION 111. That the City Foreman shall receive a salary for the year 1984 in the amount of \$18,900.00.

SECTION 1V. That the Ordinance Officer shall receive a salary for the year 1984 in the amount of \$14,000.00.

SECTION V. That the Health Officer shall receive a salary for the year 1984 in the amount of \$500.00 and the Assistant Health Officer shall receive a salary for the year 1984 in the amount of \$1,000.00.

SECTION V1. That the Clerical employees shall receive a salary for the year 1984 as per the following classifications:

Bookkeepers ----- \$10,035.00 Secretaries ---- 9,398.00 Office Clerks ---- 9,080.00 Probation ----- 7,950.00

SECTION V11. That the personnel of the City Treasurer's Office shall receive salaries for the year 1984 as per the following classifications:

Bookkeeper ----- \$ 3,345.00 Office Clerks ---- 3,026.67 Probation ----- 2,650.00

SECTION VIII. That the metermaids shall receive an hourly wage for the year 1984 in the amount of \$4.30 per hour and that the metermaid probation rate for the year 1984 shall be \$3.65 per hour.

SECTION 1X. That the personnel of the Community Development Department shall receive salaries for the year 1984 as per the following classifications;

Coordinator ----- \$ 21,000.00

Housing Specialist \$ 13,640.00

Housing Inspector \$ 13,023.00

Secretary ----- \$ 9,398.00

 $\underline{\text{SECTION X.}}$ That the Fire Marshall shall receive a salary for the year 1984 in the amount of \$1,000.00
