AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID THE OFFICERS AND NON-UNION EMPLOYEES OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, PENNSYLVANIA FOR THE YEAR 1985.

BE IT ORDAINED AND ENACTED by the Council of the City of Jeannette, and it is hereby ordained and enacted as follows:
