ORDINANCE NO. 86-3

AN ORDINANCE AMENDING SECTION V OF ORDINANCE NO. 36 OF THE CITY OF JEANNETTE ENTITLED "AN ORDINANCE ESTABLISHING SEWAGE RENTALS FOR THE USE OF THE SEWAGE SYSTEM AND SEWAGE TREATMENT WORKS OF THE CITY OF JEANNETTE, AND PROVIDING FOR THE COLLECTION THEREOF, AND THE LIENING OF PROPERTY FOR NON PAYMENT THEREOF", AS AMENDED, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HEREWITH.

BE IT ORDAINED AND ENACTED, and it is hereby Ordained and Enacted by the Council of the City of Jeannette that Ordinance No. 36 of the City of Jeannette entitled "AN ORDINANCE establishing sewage rentals for the use of sewage system and sewage treatment works of the City of Jeannette, and providing for the collection thereof, and the liening of property for non-payment thereof", Ordained and Enacted by the Council of the City of Jeannette on the 20th. Day of July, 1939, as amended, be and is hereby amended as follows:

SECTION 1. That Section V of Ordinance No. 36 is hereby amended to read as follows:

SECTION V. The following annual rates for service are hereby established;

DOMESTIC USERS

Domestic Users shall be charged at the annual rate of Ninety-five dollars (\$95.00) per year.

COMMERCIAL USERS

Rates shall be based on water consumption.

1	to	25,000	gallons	\$ 115.40
25,000	to	50,000	gallons	\$ 176.95
50,000	to	75,000	gallons	\$ 225.04
75,000	to	175,000	gallons	\$ 273.13

175,000 and above shall pay sewage at the rate of \$1.96/1,000 gallons of water consumed by the account reading furnished by the Municipal Authority of Westmoreland County.

INDUSTRIAL USERS

Service Connection minimum \$ 192.34/Year Each employee \$ 5.77/Year but not less than \$1.96/1,000 gallons of water returned to sewer.
