ORDINANCE NO. <u>98-11</u>

AN ORDINANCE ESTABLISHING AREAS WHERE PARKING SHALL BE PERMITTED BY PERMIT ONLY, ESTABLISHING AREAS ON DESIGNATED STREETS AS NO PARKING AREAS, PROVIDING FOR THE ISSUANCE OF PERMITS TO RESIDENTS OF THE CITY OF JEANNETTE FOR PARKING PURPOSES AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

WHEREAS, there exists within the City of Jeannette certain areas where parking of vehicles upon the roadways interferes with emergency and other other public or essential services; and

WHEREAS, there exists within the City of Jeannette certain streets subject to over parking to the extent that residence abutting such streets have limited ability to park vehicles in front of their residences; and

WHEREAS, the Council of the City of Jeannette believes it is appropriate to designate no parking areas and permit parking areas within the City to further the health, safety and well-being of its residents.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE CITY OF JEANNETTE, AT A PUBLIC MEETING HELD THE 9 DAY OF DECEMBER, 1998, DOES HEREBY ORDAIN AND ENACT THE FOLLOWING:

- 1. The following portions of roadways existing within the City of Jeannette, are hereby established as areas where parking shall be permitted only to vehicles exhibiting a permit to be issued by the City of Jeannette:
 - a. The Western side of Jefferson Avenue from Spruce Street to Broad Street;
 - b. Both sides of Jefferson Avenue from Broad Street to Vine Street;
 - c. The North side of Broad Street from Lowry Avenue to Lewis Avenue;
 - d. Both sides of Locust Street from Jefferson Avenue to Washington Avenue;
 - e. Both sides of Spruce Street from Jefferson Avenue to Michigan Avenue;
 - f. Both sides of Vine Street from Westmoreland Avenue to Lewis Avenue;
 - g. The West side of Lewis Avenue from Park Street to Vine Street;
 - h. Both sides of Lewis Avenue from Vine Street to Broad Street;
 - i. The East side of Lewis Avenue from Broad Street to Locust Street;
 - j. Both sides of Washington Avenue from Broad Street to Park Street;
 - k. The East side of Michigan Avenue from Park Street to Vine Street;
 - 1. Both sides of Michigan Avenue from Vine Street to Broad Street;

- m. The East side of Michigan Avenue from Broad Street to a point being 30 feet South from the intersection of Michigan Avenue and Locust Street;
- n. Both sides of Michigan Avenue from Locust Street to Spruce Street;
- o. Both sides of Westmoreland Avenue from Vine Street to Broad Street; and
- p. The South side of Westmoreland Avenue from Broad Street to Pennsylvania Boulevard.
- 2. The following portions of streets situate within the City of Jeannette are hereby established as "No Parking Zones", with such "No Parking Zones" to be specifically indicated by the erection of signs designating same:
 - a. The East side of Jefferson Avenue from Broad Street to Spruce Street;
 - b. The North side of Broad Street from Lewis Avenue to Jefferson Avenue;
 - c. The South side of Broad Street from Lowry Avenue to Jefferson Avenue;
 - d. The East side of Lewis Avenue from Park Street to Vine Street:
 - e. The South side of Broad Street from Jefferson Avenue to Westmoreland Avenue; and
 - f. The South side of Spruce Street from Jefferson Avenue toward Lewis Avenue terminating at an alleyway running parallel between Jefferson and Lewis Avenue.
- 3. Permits for parking within the aforesaid designated permit parking areas shall be issued by the Chief of Police or his designee. Such permit shall only be issued to residents of the City of Jeannette residing on property abutting a permit parking area.

- 4. Any person parking a vehicle without a permit in an area designated as a "Permit Parking Area" shall be guilty of a Summary Offense and, upon conviction thereof, shall be subject to a fine of not less than Fifteen and 00/100 (\$15.00) Dollars and, in default of payment thereof, shall be subject to a period of incarceration as determined by a District Justice having jurisdiction over same. Any person parking a vehicle in an area designated as a "No Parking Area" shall be guilty of a Summary Offense and, upon conviction thereof shall be subject to a fine of not less than Fifteen and 00/100 (\$15.00) Dollars and, in default of payment thereof, shall be sentenced to a period of incarceration as may be determined by a District Justice having jurisdiction over same.
- 5. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

 However, nothing in this Ordinance shall be deemed or construed to eliminate any currently existing Permit Parking or No Parking Zones established by the City of Jeannette prior to the date of this Ordinance's adoption other than on those specific streets or roadways listed above.
