ORDINANCE NO. 07-06

AN ORDINANCE OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA ESTABLISHING STOP SIGNS ON THE NORTHEAST SIDE OF HISSAM STREET AT ITS INTERSECTION WELKER STREET; THE SOUTHWEST SIDE OF LENTZ STREET AT ITS INTERSECTION WITH WELKER STREET; THE SOUTHWEST SIDE OF JEFFERSON AVENUE AT ITS INTERSECTION WITH ELM STREET; AND THE SOUTHEAST SIDE OF CLAY AVENUE AT ITS INTERSECTION WITH CUYLER AVENUE, ALL IN THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA

WHEREAS, the Council of the City of Jeannette is vested with powers under the Third Class City Code to regulate traffic on City Streets within the geopolitical boundaries of the City of Jeannette; and

WHEREAS, the Council of the City of Jeannette is permitted to construct traffic control devises in the form of stop signs to control and regulate traffic flow on such roadways; and

WHEREAS, the Council of the City of Jeannette desires to provide for the construction and maintenance of stop signs along Hissam Street, Lentz Street, Jefferson Avenue and Clay Avenue, all public roadways within the City of Jeannette, Westmoreland County, Pennsylvania, as set forth hereafter.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA, HEREBY ORDAINS AND ENACTS AS FOLLOWS:

1. The Council of the City of Jeannette hereby approves the construction and maintenance of a stop sign controlling traffic traveling north on Hissam Street in the City of

Jeannette, Westmoreland County, Pennsylvania. Such stop sign shall be constructed on the northeast side of Hissam Street, at or near its intersection with the southwest side of Welker Street.

- 2. The City of Jeannette approves the construction and maintenance of a stop sign controlling and regulating traffic traveling south along Lentz Street in the City of Jeannette, Westmoreland County, Pennsylvania. Such stop sign shall be constructed on the southwest side of Lentz Street, at or near its intersection with the northeast side of Welker Street.
- 3. The Council of the City of Jeannette hereby approves the construction and maintenance of a stop sign controlling and regulating traffic traveling in a southerly direction along Jefferson Avenue, in the City of Jeannette, Westmoreland County, Pennsylvania. Such stop sign shall be constructed on the west side of Jefferson Avenue at or near its intersection with the northwest side of Jefferson Avenue.
- 4. The Council of the City of Jeannette hereby approves the construction and maintenance of a stop sign controlling and regulating traffic traveling in a easterly direction along Clay Avenue, in the City of Jeannette, Westmoreland County, Pennsylvania. Such stop sign shall be constructed on the southeast side of Clay Avenue at or near its intersection with the northwest side of Cuyler Avenue.
- 5. Any person who fails to come to a full and complete stop at any stop sign established hereby shall be guilty of a summary offense and, upon conviction thereof, be sentenced to a fine of \$\_25.00 and in lieu of such payment, be sentenced to a period of incarceration up to the maximum amount permissible under the laws of this Commonwealth for summary offenses.

6. The aforesaid stop sign shall be constructed under the supervision of the City Foreman, City Engineer and Chief of Police of the City of Jeannette, and be maintained by the City thereafter.

THIS ORDINANCE IS DULY ORDAINED AND ENACTED BY THE COUNCIL OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA, AND SHALL TAKE EFFECT IMMEDIATELY.
