ORDINANCE NO. 20-02

AN ORDINANCE OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 98-11, AS AMENDED, TO MAKE A PORTION OF PARK STREET AS NO PARKING; REPEALING ALL INCONSISTENT ORDINANCES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, there exists within the City of Jeannette certain areas where parking of vehicles upon the roadways interferes with emergency and other public or essential services or travel; and

WHEREAS, the City of Jeannette has established no parking areas within the City with Ordinance No. 98-11; and

WHEREAS, a study has been conducted and it has been determined that with respect to portions of Park Street: (i) the distance between the center of the center line pavement markings and the curb or edge of roadway is less than 19 feet; (ii) at the related intersections, the available corner sight distance for drivers on connecting roads is less than the necessary minimum stopping sight distance value for the driver on any through roadway; and/or (iii) the conditions of the roadway are dangerous for visibility for parked vehicles and the drivers and passengers of such vehicles; and

WHEREAS, the City of Jeannette has the power to erect official traffic-control devices pursuant to 75 Pa.C.S.A. § 6122, 67 Pa. Code § 212.5, and other statutory and regulatory sections.

- **BE IT ENACTED AND ORDAINED** by the City Council of the City of Jeannette, Westmoreland County, Commonwealth of Pennsylvania, and it is hereby enacted and ordained as follows:
- **Section 1.** Addition of Portions of Certain Street as No Parking Zone. The City hereby amends Ordinance No. 98-11, Section 2, to add and make the following portions of a roadway as a "No Parking Zone" for which a sign designating the same shall be erected:
 - a. The Northern and Southern sides of Park Street from Lowry Avenue to Lewis Avenue.
- **Section 2.** <u>Authorization</u>. The City hereby authorizes all City officials and employees to take any and all actions necessary to effectuate and enforce the addition of said portion of roadway as a "No Parking Zone" and this Ordinance, including, without limitation, the erection of any sign and the painting of any curbing or streetway.

Section 3. <u>Severability</u>. It is herein declared that the provisions of this Ordinance are severable, and if any provisions, portions, or sections of this Ordinance are declared to be illegal, invalid, or unconstitutional, the decisions of any Court, which makes declarations, shall not impair or affect any of the remaining portions of this Ordinance.

Section 4. Repealer. Any ordinance or part of any ordinance that conflicts with the provisions of this ordinance is hereby repealed to the extent of any such conflict on the effective date of this ordinance.

Section 5. <u>Effective Date</u>. This Ordinance shall become effective immediately.
