ORDINANCE NO. 76-

AN ORDINANCE vacating a certain alley lying between North Second Street Extension and Thompson Street from Green Street to Walters Street in the City of Jeannette, Westmoreland County, Pennsylvania.

WHEREAS, a majority of the owners of property abutting a certain alley between North Second Street Extension and Thompson Street from Green Street to Walters Street has petitioned the Council of the City of Jeannette to vacate said alley, and

WHEREAS, the Council of the City of Jeannette has investigated and considered said request and the granting of said request has been recommended by the Planning Commission of the City of Jeannette.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, and it is hereby Ordained and Enacted by the Council of the City of Jeannette, as follows:

SECTION I: That the alley lying between North Second Street Extension and Thompson Street from Green Street to Walters Street in the City of Jeannette, Westmoreland County, Pennsylvania, as shown on the plan prepared for the City of Jeannette by the City Engineer, attached hereto, marked Exhibit "A" and made a part hereof, be and is hereby vacated and abandoned to the end that the same may revert to the respective owners of the property abutting the same by operation of law.

SECTION II: All ordinances or parts of ordinances inconsisten herewith are hereby repealed.
