Mr. Highlands- Mr. Highlands gave the monthly financial statements of the General Fund and Capital Reserve Fund. He stated that all the MMO Payments were made into the Pension funds. He thanked council and department heads for helping with creating a balanced budget which is on the agenda for tonight's vote.

Mrs. Mozley- She gave the monthly sanitation report from the City Foreman. Chief Frye gave the monthly fire department report and stated that calls have continued to increase but with the help of the call firefighters they were able to make everything work. Additional training has occurred, and the garage door had to be repaired.

Mr. Krawtz- He gave the monthly street department report.

Mr. Antoniak- Chief Donald Johnston gave the monthly police report. Mayor Antoniak gave the monthly CDBG Report that was provided by Urban Design Ventures. He stated that the Veterans day concert that will be happening is one of the greatest events in the City and thanked all the Veterans in the City.

Michelle asked to amend the initial motion to lower the earned income tax down to 1.1% due to the no effect on the general fund and the sizable amount that is currently in our Act 205 account. Ethan stated that there should have been a discussion on this at the work session due to the research that would be needed to update council on what the end effects would be on the ACT 205 account. A second was made by Krawtz to amend the motion. Ethan stated that there is approx \$600,000-1million that will be needed to be moved from prior years OPEBS after the Auditor General office completes its audit. Michelle stated that the account should not be used as a savings account. Curtis said we had budget meetings, work sessions that never was discussed, He stated we hired Ethan, and he created the budget, I have faith in your work, We have not had to worry about layoffs, Mayor Antoniak stated that this was never mentioned during those meetings and is Grandstanding. Solicitor Witt explained the timeframe and process if the budget were to

be amended. He stated that we need to introduce the budget by the end of November, and if we do not we will not be in accordance by the 3rd class city code. Robin asked if we adopt the budget can we amend it. Solicitor Witt stated only the budget can be amended and the tax portion has to be completed by ordinance. Ethan Stated that we have a meeting scheduled already for November 28th that we can table this until that meeting and then have a discussion and introduce the budget then. However, will have to meet on December 26th the day after Christmas then to adopt the budget accordingly. A motion was then made by Mozley and seconded by Langdon to Table the budget until November 28th. Ethan then asked if anything in the future were to come up if we could please discuss this at the work session to prevent this from happing at the voting meetings. Chuck Highlands stated he made a motion to accept the budget and why was that taken acton On. Solictior Witt then explained the process that amendments take precedent over the original motion and then the tabled motion gets voted on first, then the amendment motion would get voted on, if that fails we would go back to the original motion. Mrs. Mozley stated that we really don't know where we are right now with all these different motions.
