**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JEANNETTE
APPROVING A REVISION TO THE FY 2022 CDBG PROGRAM YEAR**

A Resolution of the City Council of Jeannette, Commonwealth of Pennsylvania, authorizing the submission of a revision to the FY 2022 application to the Pennsylvania Department of Community and Economic Development for funding through the Community Development Block Grant (CDBG) Program, as authorized under the Housing and Community Development Act [42 USC 5301 and 24 CFR Part 570], and further certifying compliance with the requirements of said program.

WHEREAS, the City Council of Jeannette has the legal authority and responsibility under Act 179 to apply for Community Development Block Grant funds; and

WHEREAS, the City Council discussed the reduction in the Clearance and Demolition line item from \$76,277.00 to \$73,600.54, a reduction in General Administration funds from \$55,812.00 to \$54,881.20, and a corresponding increase in the Street Improvements – School Street line item from \$113,477.00 to \$117,084.26 at the City Council Meeting; and

WHEREAS, there is a need to add funds to the Street Improvements – School Street activity to complete all outstanding costs and there is a small surplus of funds in the Clearance and Demolition and General Administration activities; and

WHEREAS, the City of Jeannette is familiar with the requirements of the program as provided for in the Housing and Community Development Act (HCDA) and the Community Development Block Grant regulations; and


WHEREAS, the City of Jeannette wishes to revise its budget for the FY 2022 CDBG funds.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Jeannette that its Mayor is authorized to submit this revision to the FY 2022 CDBG Program Year to the Department of Community and Economic Development for Community Development Block Grant funds for the purposes aforesaid; and

BE IT FURTHER RESOLVED, if CDBG funds are determined by the Pennsylvania Department of Community and Economic Development to be expended on ineligible program costs or do not meet a national objective, the City of Jeannette agrees to repay the proportion deemed ineligible from non-federal sources.

BE IT FURTHER RESOLVED that the Mayor of the City of Jeannette is empowered to place his signature, on behalf of the governing body, on necessary application forms and affix thereto the official seal of the City of Jeannette.
