ORDINANCE NO. 91-7

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID THE OFFICERS AND NON-UNION EMPLOYEES OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, PENNSYLVANIA FOR THE YEAR 1991.

BE IT ORDAINED AND ENACTED, By the Council of the City of Jeannette, and it is hereby Ordained and Enacted as follows:

SECTION 1. That the City Clerk/Chief Accountant shall receive a salary for the year 1991 in the amount of ~~\$36,153.00~~ <sup>36,504.00</sup> PFT 9/18/91

SECTION 2. That the City Solicitor shall receive s salary for the year 1991 in the amount of \$17,500.00

SECTION 3. That the City Foreman shall receive a salary for the year 1991 in the amount of ~~\$29,149.00~~ <sup>29,432.00</sup> PFT 9/18/91

SECTION 4. That the Ordinance Officer shall receive a salary for the year 1991 in the amount of \$23,500.00

SECTION 5. That the Health Officer shall receive a salary for the year 1991 in the amount of \$500.00 and the Assistant Health Officer shall receive a salary for the year 1991 in the amount of \$1,625.00

SECTION 6. That the City Finance Coordinator shall receive a salary for the year 1991 in the amount of \$20,000.00

SECTION 7. That the Clerical Employees shall receive a salary for the year 1991 as per the following classifications:

Bookkeepers	\$15,370.00
Secretaries	\$14,310.00
Office Clerks	\$14,310.00
Probation	\$10,600.00

SECTION 8.

Deputy Treasurer	\$ 393.00
Bookkeeper	\$ 6,106.67
Office Clerks	\$ 4,770.00
Probation	\$ 3,533.33

**SECTION 9.** That the metermaids shall receive an hourly wage for the year 1991 in the amount of \$6.36 per hour and the meter maid probation rate for the year 1991 shall be minimum wage.

**SECTION 10.** That the personnel of the Community Development Department shall receive salaries for the year 1991 as per the following classification:

Housing Specialist	\$ 18,900.00
Housing Inspector	\$ 18,900.00
Secretary	\$ 14,310.00

**SECTION 11.** That the Fire Marshall shall receive a salary for the year 1991 in the amount of \$500.00
