ORDINANCE NO. 87-1

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID THE OFFICERS AND NON-UNION EMPLOYEES OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, PENNSYLVANIA FOR THE YEAR 1987.

BE IT ORDAINED AND ENACTED by the Council of the City of Jeannette, and it is hereby ordained and enacted as follows:

SECTION I. That the City Clerk/Chief Accountant shall receive a salary for the year 1987 in the amount of \$31,000.00

SECTION II. That the City Solicitor shall receive a salary for the year 1987 in the amount of \$11,000.00

SECTION III. That the City Foreman shall receive a salary for the year 1987 in the amount of \$25,000.00

SECTION IV. That the Ordinance Officer shall receive a salary for the year 1987 in the amount of \$17,800.00

SECTION V. That the Health Officer shall receive a salary for the year 1987 in the amount of \$500.00 and the Assistant Health Officer shall receive a salary for the year 1987 in the amount of \$1,300.00

SECTION VI. That the Clerical employees shall receive a salary for the year 1987 as per the following classifications:

Bookkeeper/Payroll Supervisor	\$ 13,750.00
Bookkeepers	\$ 12,600.00
Secretaries	\$ 11,798.00
Office Clerks	\$ 11,480.00
Probation	\$ 8,500.00

SECTION VII. That the personnel of the City Treasurer's Office shall receive salaries for the year 1987 as per the following classifications:

Bookkeeper	\$ 4,250.00
Office Clerks	\$ 3,827.00
Probation	\$ 2,833.00

SECTION VIII. That the metermaids shall receive an hourly wage for the year 1987 in the amount of \$5.60 per hour and that the meter maid probation rate for the year 1987 shall be \$4.00 per hour.

SECTION IX. That the personnel of the Community Development Department shall receive salaries for the year 1987 as per the following classifications:

Coordinator	\$ 28,000.00
Housing Specialist	\$ 16,495.00
Housing Inspector	\$ 16,495.00
Secretary	\$ 11,798.00


SECTION X. That the Fire Marshall shall receive a salary for the year 1987 in the amount of \$500.00
