Jeannette Community Park Rules and Regulations

**\*\*\*Updated / Effective 01/01/2026\*\*\***

**The Jeannette Community Park is intended for the use of residents of the City of Jeannette. Jeannette residents and organizations receive first priority in the rental dates. Dates still available will be rented on a first come first served basis.**

**PARK REGULATIONS ARE AS FOLLOWS:**

- **The park is open from May 1 until September 30 each year. It is open daily from 9:00 am until 9:00 pm.**
- **The maximum number of people permitted at any park rental function is 200.**
- **The Jeannette Police Department has jurisdiction within the park which is legally annexed to the City of Jeannette.**

- **Pets are not permitted within the park. NO EXCEPTIONS - City Ordinance #0802.**
- **Bicycles, skateboards and motorized vehicles such as dirt bikes, quads, etc. are not permitted within the park**
- **No refund of a rental fee will be made in the event of cancellation. If the park can be rented a full refund will be given, however, if it cannot be rented only ½ of the rental fee will be refunded. The security deposit will be returned if the park is left in the condition in which it was rented. That is determined by The City of Jeannette. All trash must be put in the garbage dumpster and if using water balloons the remains must be disposed of. If you remove picnic tables from the pavilion, they must be returned and if tables are rearranged in the pavilion, they must be returned to their original position. Diagram is posted in the kitchen.**
- **Individuals or organizations renting the Jeannette Community Park are responsible for the conduct and safety of themselves and their guests. Park facilities are to be left clean and in good working condition following each rental. Please refer to the number posted in the kitchen in the event of an issue with the toilets. Do not allow a malfunctioning toilet to go unreported. The park is under camera surveillance at all times.**
- **Anyone who misuses the park facilities or not following the rules and regulations will be asked to vacate the park. Those vacated from the park will not be permitted to secure further rental reservations. This applies to both groups and individuals.**

- **Only the pavilion and the ball field are closed to the public. The remainder of the park may be used by the public during regular rental period.**
