HOW DO I START MY SANITATION / TRASH SERVICE?

You don't have to do anything because we never technically "stop" garbage pickup. By the time you go to your real estate closing, the settlement company has already asked us for a municipal no lien letter so that they can pro-rate the garbage bill at closing. Once the deed is recorded at the Courthouse, we will automatically switch the garbage bill (and taxes) into your name. You still have to deal all the utility companies to get everything else switched into your name, but here at the city-level we take care of that automatically for you.

Oh, and we only bill twice a year for garbage. The face amount of the bill is currently \$156.00. There is a slight discount for paying within the first few months, and also a 15% discount for senior citizens (65+). (Approx. \$132.00)

WHAT'S WITH THE GREEN GARBAGE BAGS?

One of the first unique things you may have noticed in town is that we require trash to be put out in official City of Jeannette green garbage bags (Ordinance 12-04). Bags are \$10.00 a roll (25 bags) and are sold in the following 5 locations:

- Treasurer's Office (City Hall) – 110 South Second Street
- Arlington Market – 415 Harrison Avenue
- Candy's Corner Deli – 643 Division Street
- Jaytown Vape – 303 Clay Avenue
- Sunoco – 1110 Lowry Avenue
- Jeannette Library – 500 Magee Avenue

Bags are permitted to be placed on the curb up to 24 hours prior to garbage pickup (so basically, the day before). Please see the "Garbage Pickup Schedule" (Exhibit "A") to see when your pickup is. Weight allowance is 35 lbs. per bag.

GARBAGE STICKERS AS AN ALTERNATIVE

Effective summer of 2018, City Council instituted the sale of GREEN STICKERS that be used as an alternative to the green garbage bags. They are sold in sheets of 10 for \$4.00 or sheets of 5 for \$2.00. When you break it down, it's the same price as the bags but it comes down to personal preference. These stickers are only sold at the Tax Office. Weight allowance is still 35 lbs. per bag.

DOES JEANNETTE HAVE RECYCLING?

Yes, we have mandatory recycling of clear glass and metal. We also take newspaper & cardboard. Glass is to be placed in an official City of Jeannette blue recycling bin. Metal is a red bin. These bins are free of charge and available at the Tax Office. Recycling is EVERY OTHER week on your normal garbage day. Check the calendar at www.cityofjeannette.com to see which week is recycling week. Please tie up/secure your newspaper if setting it out.

WHAT IF I HAVE A LARGE ITEM, I NEED TO GET RID OF?

We sell what we call "special pickup (PINK) stickers" at the Tax Office for various large items (couches, chairs, dressers, etc.) The fee schedule for these items can be found on Exhibit "B". Once purchased, you just stick the stickers on what you'd like to throw out and put it on the curb with your garbage on your normal pickup day.

WHAT IF I HAVE A LOT OF LARGE ITEMS AND DON'T FEEL LIKE BUYING A MILLION STICKERS?

If you have multiple items to get rid of, a dumpster might be your best bet. We currently rent the following size dumpsters: 6-yard dumpster (6'x9'x4' deep) - \$185.00

A short form can be filled out in the Treasurer's Office or online for a dumpster rental, and you get it for 7 days or until you fill them up. If you need a bigger dumpster than what we offer, there is a second option: You can bring in a large dumpster from a private company as long as you apply for what we call a "Rolloff Permit" with the city. This permit is \$60.00/week and allows you to bring in a private dumpster.

I HEARD THE CITY WILL CHIP BUSH/TREE TRIMMINGS, IS THIS TRUE?

Yes, the City Garage offers this service every Wednesday (weather permitting) for \$20.00 (small) or \$40.00 (large). If you have trimming that you'd like picked up and/or mulched, call the tax office at 724-527-4000 ext. 14, 15, 16 or stop in to make payment and you will be put on the schedule.

WILL THE CITY SANITATION DEPARTMENT PICK UP ANYTHING?

No. There are a few items that we as a city are not permitted to take to the landfill. These include electronics, appliances, paint, and most building supplies. If you need to get rid of these items, please see Exhibit "C": This is the place that we refer anyone to that is looking to get rid of items that are not approved for disposal with the City.

WAIT, IF GARBAGE PICKUP NEVER STOPS, WHAT HAPPENS IF MY HOUSE BECOMES VACANT?

If your house is vacant for any extended period of time, we can exonerate your garbage bill. We can exonerate anywhere from 1-6 months at a time. So, if you usually go to Florida during the winter months, or are having trouble finding a tenant for one of your rentals, or are handling an estate and the house is sitting vacant, come in and let us know. There is a simple form we give you to fill out (also found on our website). Hold on to your bill, and AFTER the billing cycle is over, bring the completed form back to us and we will retroactively exonerate your garbage bill balance. In the past, these forms needed to be notarized, but they don't anymore.

WHAT IF I WANT TO RENT OUT MY PROPERTY?

If you'd like to rent out your property, there is an Occupancy Permit application available both in the office and online. The fee for the inspection is \$100.00. Upon payment, we will schedule a date/time with our Fire Department. Once the Fire Department passes the property, the permit will be issued on the spot. This will need to be done every ten years if no change of tenant. If there is a change of tenants within that timeframe, a re-inspection will be required.

WHAT'S THE DIFFERENCE BETWEEN PROPERTY MAINTENANCE & ZONING/CODE ENFORCEMENT?

Ah, excellent question!

Property Maintenance is stuff like tall grass, junk vehicles in the yard (if on the street, this is a police matter – call them), or garbage laying on someone's property. Our property maintenance is currently handled by **Vince Pascarella** and he can be reached at **724-527-4000 ext. 43**. Blight/Vacancy/Junk/Vehicles can also be reported online at www.cityofjeannette.com. **PLEASE NOTE THAT HOUSE NUMBERS ARE REQUIRED TO BE VISIBLY DISPLAYED ON EACH PROPERTY.**

Code Enforcement/Zoning is stuff like permits for any commercial project, in-ground or above-ground pools, fences, decks, sheds, additions to houses, etc. Our Code Enforcement/Zoning officer is **Bill Whetzel** and can be reached at **724-527-4000 ext. 20**.

AGREEMENT FOR TEMPORARY LEASING OF DUMPSTER

**THE CITY OF JEANNETTE WILL NOT ACCEPT ANY HEAVY CONSTRUCTION
MATERIALS, WOODEN DECKING & SCRAPS**

1. This lease is for a maximum period of seven (7) days, unless extended as set forth below.
2. The pull fee shall be paid in advance to the *City Treasurer* prior to delivery of the dumpster to the property. The City will remove the dumpster from the property following the first pull, unless the lessee notifies the Treasurer and driver that it requires the dumpster for an additional seven (7) days.

The Following Rules Shall Apply to the Filling of the Dumpster

- A. FILL THE DUMPSTER UNIFORMLY.
- B. DO NOT OVERFILL ABOVE THE TOP RAIL.
- C. ABSOLUTELY **NO** TIRES, ELECTRONICS, CONCRETE OF ANY KIND, BRICKS, SHINGLES, CONSTRUCTION MATERIALS, OR ASHES IN THE DUMPSTER.
- D. ALL FOOD, WASTE OR OTHER ODOR CAUSING WASTE MUST BE PLACED IN GARBAGE BAGS AND TIED SHUT.

**If These Rules & Regulations Are Not Followed Correctly, the Lessee
Will be Charged an Additional Fee(s) to Their Current Garbage Bill.**

"RIGHT OF ENTRY AND RELEASE FROM DAMAGES: As indicated by my signature and date below, I hereby (1) irrevocably authorize and permit the City of Jeannette, its agents, employees, and contractors, to access the premises (including behind and beyond the curb line) for the purpose of locating, servicing, and maintaining dumpster(s) that the aforesaid owner/lessee has placed, requested to be placed, or caused to be placed on the premises, and (2) release, discharge, indemnify, save, and hold harmless the City of Jeannette, its agents, employees, and contractors, from any claim for damages or losses resulting from injury to any person (including death or serious bodily injury) and/or property caused by, resulting from, or in connection with any act or omission by any person in locating, maintaining, and/or servicing said dumpster(s). By execution of this Agreement, the undersigned, individually and/or as an authorized representative on behalf of any corporation, partnership, or other entity, do hereby certify that I have the authority to execute the within Agreement and agree to the binding terms set forth above."
